Additionally Recommended Courses

The following courses are recommended for students desiring more training in a specific area:

- POE 1550 – Street Survival (enrollment in LE program), 2 credits
- POE 2531 – Basic Firearms (enrollment in LE program AND instructor approval), 1 credit
- POE 2540 – POST Preparation (completion of/enrollment in final semester of accredited PPOE program with skills), 1 credit
- POE 2550 – Field Training Experience (completion of 32 first-year credits or equivalent), 2 credits
- POE 2597 – Spontaneous Knife Defense (enrollment in LE program), 1 credit

Students need to meet prerequisite of course (listed in parentheses) prior to enrolling, and course sections will only be held if minimum enrollment in a particular course is reached.

Program Description

This program prepares individuals to perform the duties of police and public security officers, including patrol and investigative activities, traffic control, crowd control and public relations, witness interviewing, evidence collection and management, basic crime prevention methods, weapon and equipment operation and maintenance, report preparation, and other routine law enforcement responsibilities.
